### **Terms of Use**

## **Brief Explanation**

This legal documentation outlines the rules and guidelines using the app: a contract between the user and developer.

#### **Definitions**

For the purposes of these Terms of Use, the following terms shall have the following meanings:

- "Application" refers to Raijin, including all services and features offered through it.
